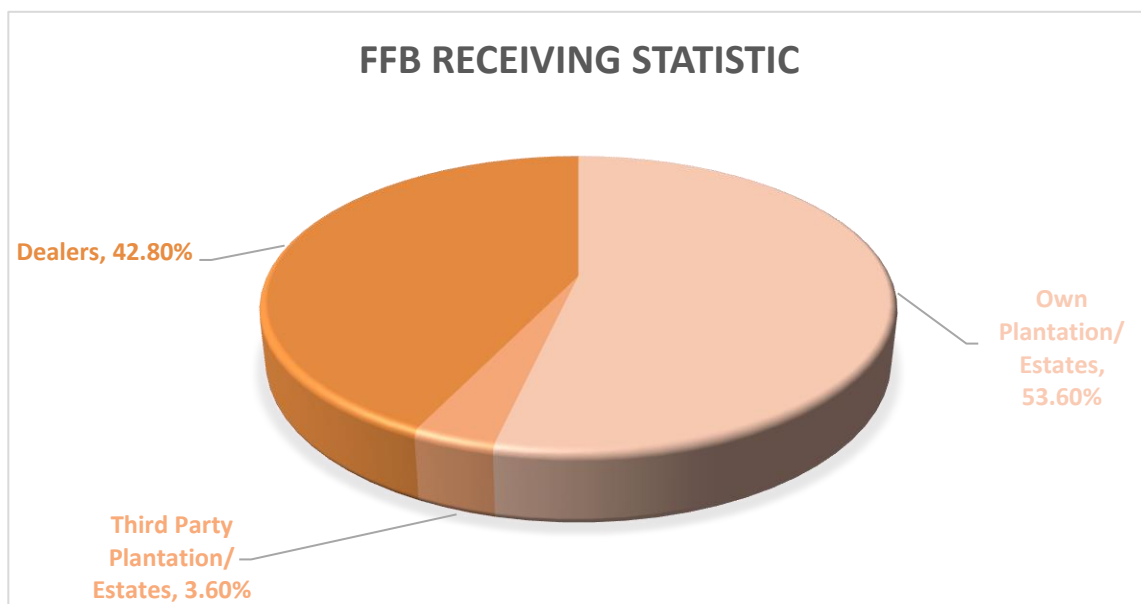

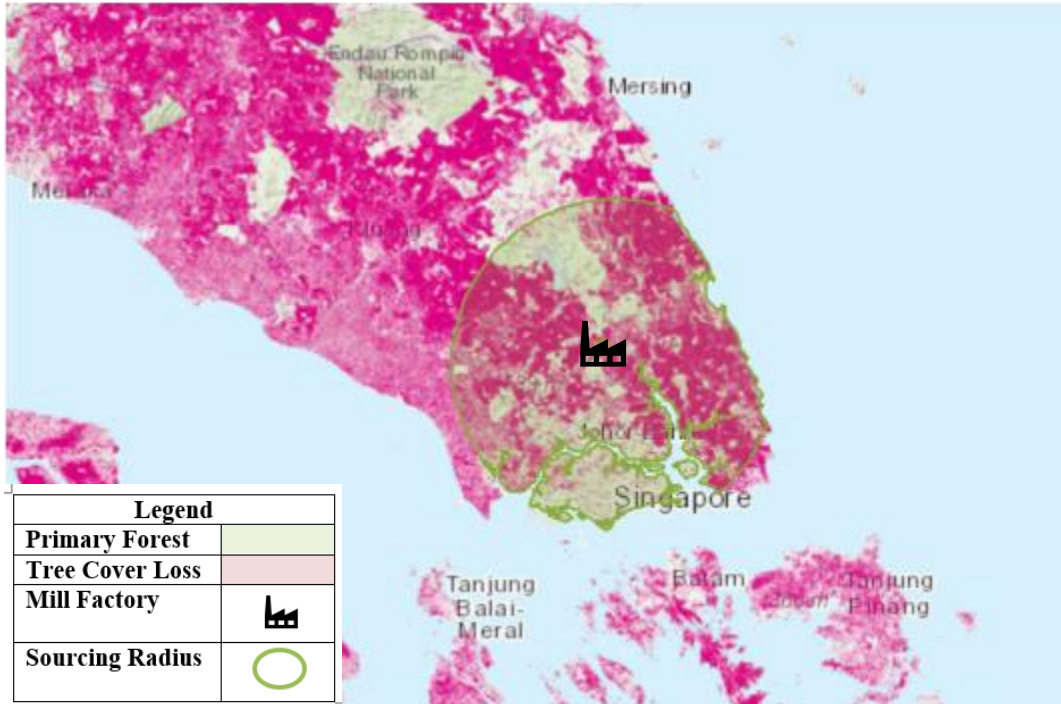
## B. Environmental Risk Analysis
